CTC is among the 662 companies listed on the 2020WOB Web site as a Winning Company; in total, the Web site lists 1,820 companies in its [Gender Diversity Directory](#). In addition to Winning “W” companies, the directory shows:

- “V” companies that are “very close” to having 20% of women on their board.
- “T” companies that have only one “token” woman on their board.
- “Z” companies that have “zero” women on their board.

Women hold just a small number of corporate board seats, [according to 2020WOB](#). In 2015, the 2020WOB Gender Diversity Index of Fortune 1000 companies showed that 17.9% of corporate directors were women. This is a small number when you consider that: women comprise about half of the total U.S. workforce; hold half of all management positions; are responsible for almost 80% of all consumer spending; and account for 10 million majority-owned, privately-held firms in the U.S., employing over 13 million people and generating over \$1.9 trillion in sales.
